Ordinance to Amend the Eighth Bavarian Infection Protection Measures Ordinance

of 12 November 2020

In accordance with § 32 sentence 1 IfSG (German Infection Protection Act) of 20 July 2000 (*Federal Law Gazette I* p. 1045), last amended by Article 5 of the Act of 19 June 2020 (*Federal Law Gazette I* p. 1385), in conjunction with Article 9 No. 5 of the Ordinance on Responsibility to Issue Decrees (DelV) of 28 January 2014 (*Law and Ordinance Gazette* p. 22, BayRS 103-2-V), which was last amended by ordinance of 13 January 2020 (*Law and Ordinance Gazette* p. 11), the Bavarian State Ministry of Health and Care orders:

§ 1

The Eighth Bavarian Infection Protection Measures Ordinance (8th BayIfSMV) of 30 October 2020 (Bavarian Ministerial Gazette No. 616, BayRS 2126-1-12-G) is amended as follows:

1. Article 10 is amended as follows:

a) Sub-para. 3 is worded as follows:

“(3) 1The operation and use of sports halls, sports grounds, fitness studios dance schools and other sports facilities is prohibited. 2In deviation from sentence 1, the operation and use of sports facilities for the purposes specified in sub-para 1 sentence 1 in the open air is permitted. 3Sub-para 2 and Article 18 are not affected.”

b) Sub-para 4 is repealed.

2. Article 27 no. 7 is worded as follows:

„7. plays sport in breach of Article 10 sub-para. 1 or 2, allows in spectators in breach of Article 10 sub-para 2 no. 1, or operates or uses sports halls, sports grounds, fitness studios, dance schools or other sports facilities in breach of Article 10 sub-para 3,”

§ 2

This Ordinance takes effect on 13 November 2020.
